

# TIMELINE CHARTS FOR THE SUBMISSION AND REVIEW OF FIFTH-YEAR INTERIM REPORTS

## FOR REAFFIRMATION CLASSES 2022 THRU 2027

*(Revised: June 2017)*

### **Steps for determining dates for submission of Fifth-Year Interim Reports**

1. **Determine next reaffirmation date.** *If you are unsure regarding your institution's next reaffirmation date, look up the date by accessing the Commission's main menu of its web page ([www.sacscoc.org](http://www.sacscoc.org)), clicking onto your state on the map of the main menu page, clicking onto your institution on the list of institutions in your state, clicking onto "additional info" on your institution's page, and looking under "next reaffirmation."*
  
2. **Determine if Track A institution or Track B institution.** *Track A institutions are those that offer only undergraduate degrees; Track B institutions offer graduate degrees.*
  
3. ***Referring to the Charts below, find next reaffirmation date and then follow the timeline for your institution's respective Track.***
